

Restated Articles Of Incorporation
of
Athens Radio Club, Inc.

Article 1

The name of the corporation is ATHENS RADIO CLUB, INC.

Article 2

The corporation is organized pursuant to the Georgia Nonprofit Corporation Code.

Article 3

The period of duration of the corporation is perpetual.

Article 4

The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. All references to Sections in these Articles refer to the Internal Revenue Code of 1986 as amended to comparable Sections of subsequent internal revenue laws. Specifically, the corporation is organized to provide an organization to promote Amateur Radio in accordance with Federal Communications Commission Regulations Part 97 which states five basic principles: “(a) Recognition and enhancement of the value of the amateur service to the public as a voluntary noncommercial communication service, particularly with respect to providing emergency communications; (b) Continuation and extension of the amateur’s proven ability to contribute to the advancement of the radio art; (c) Encouragement and improvement of the amateur service through rules which provide for advancing skills in both the communications and technical phases of the art; (d) Expansion of the existing reservoir within the amateur radio service of trained operators,

technicians, and electronics experts; and (e) Continuation and extension of the amateur's unique ability to enhance international goodwill." (Part 97 Subpart A § 97.1) In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted under the Georgia Corporation Code for Nonprofit Corporations, whether related to the foregoing purposes, and to do all things necessary proper and consistent with maintaining tax exempt status under section 501 (c)(3).

Article 5

The corporation will have members.

Article 6

The street address of the registered office is 450 Ponderosa Dr., Athens, GA 30605. The registered agent at such address is Erwin E. Greene. The county of the registered office is Clarke.

Article 7

The Board of Directors will consist of the members of the Athens Radio Club, Inc.'s Executive Committee, to wit:

Article 8

The internal affairs of the corporation shall be regulated by its Board of Directors; and, the day-to-day business of the corporation will be conducted by the officers elected by the membership. Upon dissolution of the corporation, its assets shall be disposed of exclusively for the purposes of the corporation or distributed to such organizations organized and operated exclusively for charitable purposes which shall, at the time, qualify as exempt organizations under Section 501(c)(3).

Article 9

No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or corporation having a personal or private interest in the corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of the corporation shall be limited to reasonable amounts. No substantial amount of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation and this corporation shall not intervene in any political campaign on behalf of or in opposition to any candidate for public office in any manner whatsoever including, but not limited to, the publishing or distributing of statements. This corporation shall not take any action not permitted by the law.

Article 10

The principal mailing address of the corporation is Post Office Box 782, Athens, GA 30603-0782.

Article 11

The Restated Articles of Incorporation was duly adopted by a sufficient vote of the Directors without member approval as member approval was not required.

Article 12

The date of the adoption of the Restated Articles of Incorporation was May 13, 2011.
